

# Submit Nominations for Carolinas Chapter ASID Recognition Awards for 2019

## **PURPOSE:**

Carolinas Chapter ASID honors those who inspire us with exemplary service to the Chapter and our profession. We are looking for individuals, Industry Partners, and institutions who qualify for the **CAROLINAS CHAPTER AWARD**, **DORA GRAY DISTINGUISHED DESIGNER AWARD**, **EDUCATION AWARD**, **MEDIA AWARD**, and **INDUSTRY PARTNER AWARD**. ## **DEADLINE:**

All nominating and supporting letters for Awards are due by 11:59 PM on July 5, 2019. All materials received after that time will be **ineligible** for consideration.

## **NOMINATION PROCESS:**

### **HOW TO SUBMIT NOMINATIONS:**

- ❑ Current ASID members, of all appellations including Industry Partner and Student, may make nominations to the Awards Committee.
- Nomination materials include a letter of nomination and references. NOTE: Only **ONE** letter of support for any nominee may be submitted by a person or persons associated with the employment of the nominee—those who supervise or are employed by the nominee.
- ❑ The nomination materials must be submitted via one single packet to include nomination letters and reference letters.
- ❑ Send packet of materials to the Administrator who will forward nominations to the Awards Committee.

## **JUDGING CRITERIA:**

Judges will select **ONLY** from nominations from ASID members that are complete and arrive by the published deadline.

## **IMPORTANT NOTES:**

Please honor members by carefully responding to this request. Remember, you may be nominated by someone else, so take time to nominate those who deserve recognition. Carolinas Chapter ASID Recognition Awards acknowledge those who lead by example.

Only **ONE** Chapter Recognition Award documentation is presented in each Category, *regardless of the winner being part of a group or a single individual. If a group wants multiple documentation, each additional Award requires payment (determined annually) to the Chapter at the time of Award notification.*

# CHAPTER RECOGNITION AWARD

## PURPOSE:

“Will recognize and honor a member or non-member who had made an outstanding volunteer contribution of significance to the interior design community over a period of years. In addition, this honoree has demonstrated a positive public reflection of the Profession of Interior Design and especially of ASID to the community at large. The Award may be given to an individual or organization based upon a specific action or cumulative service.”

## NOMINATION CRITERIA:

### ? *This Award is designed to:*

- Recognize outstanding volunteer service to the interior design community over a period of years and with significant Chapter-wide impact.
- In addition, the nominee should show attention to social concerns within the interior design profession and express creative, innovative concepts that have advanced the profession.
- This Award is also meant to take into consideration service to the Carolinas Chapter ASID and to recognize the relationship between the community as a whole and the volunteer as an ambassador for ASID.

### ? *Eligibility:*

- An individual
- Multiple individuals
- An industry, or
- An organization

**The candidates may be ASID members or non-members and/or groups or organizations.**

### ? *How To Nominate:*

- **MUST** be nominated in **WRITING** by one (1) ASID member **with DETAILED documentation** of the nominee’s specific action or cumulative service.
- **MUST** be accompanied by **THREE (3)** supporting ASID members' letters of recommendation, only one of which may be submitted by a person or persons associated with the employment of the nominee—those who supervise or are employed by the nominee.
- **NOTE:** *Current Chapter President is **INELIGIBLE** for this award.*

# CHAPTER RECOGNITION AWARD ASID CAROLINAS DORA GRAY DISTINGUISHED DESIGNER

## PURPOSE:

*“Will recognize and honor a Carolinas Chapter ASID designer who had made continuous outstanding contributions toward achieving ASID’s goal of excellence. This Award is based on the designer’s professional achievements demonstrating creative and innovative concepts, as well as service to their community, and to the Carolinas Chapter ASID.”*

## NOMINATION CRITERIA:

### ? This Award is designed to:

- Recognize an ASID **professional** member who exemplifies a commitment to the profession as demonstrated by a significant, high quality body of work representing excellence in interior design.
- This Award is also based on the candidate’s professional achievements as exemplified by design work over the career, and by contributions to society and to the Chapter.

**The Dora Gary Award is based on the National ASID Designer of Distinction Award and is the most important award conveyed by the Chapter.**

**The National ASID Designer of Distinction Award recognizes an ASID Professional member who exemplifies a commitment to the profession as demonstrated by a significant, high-quality body of work representing excellence in interior design.**

### ? Eligibility:

- Have been widely published and/or have received Design Awards.
- Be active in their community and in the Chapter with demonstrable accomplishments of value.
- Demonstrate ASID’s goals of excellence.
- Be an ASID **professional** member in good standing for at least ten years.

### ? How To Nominate:

- **MUST** be nominated in **WRITING** by one (1) ASID member **with DETAILED documentation** of the nominee's Awards, specific actions, and cumulative service.
- **MUST** be accompanied by **THREE (3)** supporting ASID members' letters of recommendation, only one of which may be submitted by a person or persons associated with the employment of the nominee—those who supervise or are employed by the nominee.

# CHAPTER RECOGNITION AWARD EDUCATION AWARD

## PURPOSE:

“Will recognize and honor an individual, organization or school that has made an outstanding contribution in Design Education of major or long-term significance providing Chapter-wide impact. The Award may be given to an individual or organization based upon a specific action or cumulative service.”

## NOMINATION CRITERIA:

### ? *This Award is designed to:*

- Recognize a significant **professional** contribution to interior design education in the Chapter. The person or group shall have performed long-term acts of outstanding professional significance, preferably with Chapter-wide impact.
- Highlight creative and intellectual contributions to design education through teaching, research, administration or writing.

**Nominees must demonstrate a lasting impact and inspiration to colleagues, students and the interior design profession.**

### ? *Eligibility:*

- A person(s)
- An educator
- A school
- An industry, or
- An organization

**The candidates may be ASID members or non-members and/or groups or organizations.**

### ? *How To Nominate:*

- **MUST** be nominated in **WRITING** by one ASID member **with DETAILED documentation of** the nominee's specific action or cumulative service.
- **MUST** be accompanied by **THREE (3)** supporting ASID members' letters of recommendation, only one of which may be submitted by a person or persons associated with the employment of the nominee—those who supervise or are employed by the nominee.

# CHAPTER RECOGNITION AWARD MEDIA AWARD

## PURPOSE:

“Will recognize and honor an individual, organization, publication, or business that has made an outstanding contribution of professional significance, providing Chapter-wide impact through the Media to promote the Profession of Interior Design and ASID. The Award may be given to an individual or organization based upon a specific action or cumulative service.”

## NOMINATION CRITERIA:

- ❓ *This Award is designed to:*
  - Recognize exceptional support and/or a significant professional contribution by a member(s) of the media to promote the profession of Interior Design.
  - The nominated entity must be actively working to promote the professionalism of Interior Design and especially ASID within the media.
  
- ❓ *Eligibility:*
  - An individual
  - Multiple individuals
  - A publication
  - An industry, or
  - An organization

**The candidates may be ASID members, ASID IP Members or non-members and/or groups or organizations.**

- ❓ *How To Nominate:*
  - **MUST** be nominated in **WRITING** by one ASID member **with DETAILED documentation of** the nominee's specific action or cumulative service.
  - **MUST** be accompanied by **THREE (3)** supporting ASID members' letters of recommendation, only one of which may be submitted by a person or persons associated with the employment of the nominee—those who supervise or are employed by the nominee.

# CHAPTER RECOGNITION AWARD INDUSTRY PARTNER AWARD

## PURPOSE:

“Will recognize and honor an individual Industry Partner member or Company that has made an outstanding contribution of professional significance providing Chapter-wide impact through the promotion of the Profession of Interior Design, particularly ASID. The Award may be given to the individual or to the organization based upon a specific action or cumulative service.”

## NOMINATION CRITERIA:

- *This Award is designed to:*
  - Recognize the significant professional contribution by an Industry Partner member or entire Company member of ASID, which helps to promote and advance the profession of Interior Design and especially ASID.
  - This Award may be given to the individual or to the organization based upon a specific action or cumulative service and must show dedication to the profession.
  
- *Eligibility:*
  - An Industry Partner member or Company participating actively in the activities of Carolinas Chapter ASID.
  - Makes conspicuous contributions that advance the Chapter.
  - Provides exemplary service to the Interior Design profession.
  
- *How To Nominate:*
  - **MUST** be nominated in **WRITING** by one ASID member **with DETAILED documentation of** specific action or cumulative service, citing professional achievements, outstanding leadership contributions, social concerns, as addressed by the nominee.
  - **MUST** be accompanied by **THREE (3)** supporting ASID members' letters of recommendation, only one of which may be submitted by a person or persons associated with the employment of the nominee—those who supervise or are employed by the nominee. It is preferable that recommendations come from **both** ASID practitioner members and IP members.
